Venue Hire Terms and Conditions

The clubhouse is available for hire and can be used for a variety of functions such as birthday and engagement parties, wedding receptions and anniversaries. The Club has both indoor and covered outdoor areas as well as seating for up to 100 people. There is a licensed bar and limited kitchen facilities are available. Please see below for more information.

To ensure the smooth operation of your function, we ask that you read the terms and conditions of this contract. Should you have any questions, please do not hesitate to call the Club for assistance.

Booking your function

- The standard venue hire charge of \$150 is applicable to all functions and a security deposit of \$250 (or \$450 in cases where the majority of attendees are aged 21 or less) also applies. The venue is NOT available for 18th birthday parties.
- Confirmation of a function will only be recognised when a deposit is received. The required security deposit and venue hire fee (50% of total cost) must be received by the Club no later than 14 days prior to the scheduled event. If the deposit is not received by the due date, Nerang Soccer Club reserves the right to cancel the reservation for the venue.
- All relevant details of the function (numbers attending, start/end times etc) must be confirmed no later than 7 days prior to the function or event together with balance of hire fee. Accepted payment methods are cash or Visa/MasterCard.
- The standard hire period extends from 6:30pm – 12 midnight with time available for room decoration to be negotiated on 'as-required' basis.
- Subject to no damage being caused during the event, the security deposit is fully refundable. The cost of any and all damage caused during the hire will be recovered from the hirer. Should this amount exceed the deposit, the hirer will be liable for the difference.
- The venue is licensed. No alcohol is to be brought on to the premises in accordance with Queensland Liquor Licensing laws.
- Where matters beyond the control of Nerang Soccer Club impair or prevent Nerang Soccer Club performing its obligation in relation to the function, Nerang Soccer Club or its management will be released from any liabilities.
- The venue is to be thoroughly cleaned and returned to the state in which it was presented. The hirer may attend to this or Nerang Soccer Club will arrange for a fee of \$50.
- 'Open' parties advertised on social media are not permitted and may be cancelled at any time should the Club become aware of this information. No refund shall be provided in this case.



During your function

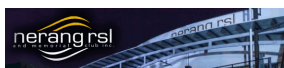
- The hirer will be responsible for ensuring the orderly behaviour of their guests and Nerang Soccer Club reserves the right to intervene where it sees fit. (See Note 1)
- Nerang Soccer Club will take all possible care, but accepts no responsibility for damage or loss of property left in the Club prior, during or after functions. The insurance of guest property is the responsibility of the guest. The hirer will be financially responsible for any damage sustained to the Club's property during functions/exhibitions.
- Nerang Soccer Club shall not be liable or in any way responsible for any loss, damage, injury or death which may be sustained or suffered to any property or by any person in or near Nerang Soccer Club by you or your guests.
- Care needs to be taken if affixing items to the walls or ceiling. Any damage caused will be the responsibility of the hirer.
- Nerang Soccer Club subscribes to the Responsible Service of Alcohol guidelines. At all times, we maintain the right to decline service of alcohol to patrons deemed intoxicated. This is at the discretion of the Nerang Soccer Club supervisor on the day of your function.
- All functions are to conclude at 12 midnight, unless prior arrangement has been made. Application for extensions must be made in writing 14 days prior to your function. Additional labour charges and license fee are applicable.
- Beverage prices are subject to change and are based on our price list at the time of your function.

Cancellation

The hirer may cancel the function by written notice to Nerang Soccer Club on the following terms:

- If notice is received more than 14 days prior to the function/event, the client will be reimbursed the full deposit.
- If notice is received within 7 to 14 days before the function/event, the client will be reimbursed 50% of the deposit.
- If notice is received less than 7 days before the function/event, the client forfeits the deposit in its entirety.

Note 1 Appropriate security – from a registered security provider and approved by Nerang Soccer Club - must be in attendance for all parties where the majority of patrons are 21 years of age or below. The area around the club must be fenced off to ensure no uninvited guests are able to enter. Both security and temporary fencing costs are to be paid by the hirer.
